BILL NO. 2003- 6

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND TO ADD NEW SECTION 10-8.3 TO ARTICLE 10 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND TO PROVIDE THAT COUNTY COUNCIL MEMBERS WHO HAVE NOT BEEN REELECTED AT THE GENERAL ELECTION IN NOVEMBER OR THE PRIMARY ELECTION IN SEPTEMBER OF AN ELECTION YEAR MAY NOT MAKE APPOINTMENTS TO COUNTY BOARDS AND/OR COMMITTEES.

Introduced, read first time, ordered posted on official bulletin board of County, County Office Building, 501 Court Lane, Cambridge, Maryland 21613.

Ordered publication for once a week for two successive weeks, and public hearing scheduled on Tuesday, May 6th, 2003, Room 110, County Office Building, 501 Court Lane, Cambridge, Maryland at 7:00 p.m.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND TO ADD NEW SECTION 10-8.3 TO ARTICLE 10 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND TO PROVIDE THAT COUNTY COUNCIL MEMBERS WHO HAVE NOT BEEN REELECTED AT THE GENERAL ELECTION IN NOVEMBER OR THE PRIMARY ELECTION IN SEPTEMBER OF AN ELECTION YEAR MAY NOT MAKE APPOINTMENTS TO COUNTY BOARDS AND/OR COMMITTEES.

SECTION ONE: Acting under Article 25A. Section S of the Annotated Code of Maryland, (the "Acts") be it ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, in legislative session, that new Section 10-8.3 be added to Article 10 of the Code of Public Local Laws of Maryland entitled "Commissioners" to read as follows:

SECTION 10-8.3, APPOINTMENTS

A County Council member who is not reelected at a November General Election or a September Primary Election may not make appointments to County Boards and/or Committees during the time immediately following the election and before the newly elected County Council takes their oath of office.

SECTION TWO: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY that General Code Publishers is directed to codify new Section 10-8.3 to Article 10 of the Code of Public Local Laws of Maryland accordingly.

SECTION THREE: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY that this Bill shall be known as Bill No. 2003- 6 of Dorchester County, Maryland and shall take effect sixty (60) days after its final passage.
