AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO AMEND CHAPTER 140, SECTION 140 -10 OF THE DORCHESTER COUNTY CODE TO CORRECT THE CITATION REFERENCE FOR VIOLATIONS AND PENALTIES SECTION OF THE SUBDIVISION REGULATIONS.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO AMEND CHAPTER 140, SECTION 140 -10 OF THE DORCHESTER COUNTY CODE TO CORRECT THE CITATION REFERENCE FOR VIOLATIONS AND PENALTIES SECTION OF THE SUBDIVISION REGULATIONS.

SECTION ONE: Acting under Article 25A, Section 5(x) of the Annotated Code of Maryland (the "Act"), be it ENACTED and ORDAINED by the County Council of Dorchester County, Maryland that Chapter 140, Section 140-10 of the Dorchester County Code be repealed and reenacted to read as follows:

§140-10. Violations and Penalties.

Any person violating this chapter shall be subject to the penalties prescribed in Article 66B, § 7.01, of the Annotated Code of Maryland, as amended, and/or ~~§-155-10B~~ "VIOLATIONS, INSPECTION AND PENALTIES" PROVISIONS of CHAPTER 155 of the Dorchester County Zoning Ordinance CODE.

SECTION TWO: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY that General Code Publishers is directed to codify amended Section 140- 10 of Chapter 140 in the Dorchester Code accordingly.

SECTION THREE: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY, that this bill shall be known as Bill No. 2004- ___ of Dorchester County, Maryland and shall take effect sixty (60) days after its final passage.
