AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY MARYLAND PURSUANT TO CHAPTER 144, SECTION 144-32 OF THE DORCHESTER COUNTY CODE AND PURSUANT TO ARTICLE 25-A, SECTION 5 (S) OF THE ANNOTATED CODE OF MARYLAND, ADDING NEW SECTION 155-20.1 TO CHAPTER 155 OF THE DORCHESTER COUNTY CODE, GRANTING AUTHORITY TO THE BOARD OF ZONING APPEALS TO HEAR AND DECIDE APPEALS FROM THE DECISION OF THE DIRECTOR OF PLANNING REGARDING ONLY THE CALCULATION OF THE AMOUNT OF THE BUILDING EXCISE TAX UNDER CHAPTER 144 OF THE DORCHESTER COUNTY CODE.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY MARYLAND PURSUANT TO CHAPTER 144, SECTION 144-32 OF THE DORCHESTER COUNTY CODE AND PURSUANT TO ARTICLE 25-A, SECTION 5 (S) OF THE ANNOTATED CODE OF MARYLAND, ADDING NEW SECTION 155-20.1 TO CHAPTER 155 OF THE DORCHESTER COUNTY CODE, GRANTING AUTHORITY TO THE BOARD OF ZONING APPEALS TO HEAR AND DECIDE APPEALS FROM THE DECISION OF THE DIRECTOR OF PLANNING REGARDING ONLY THE CALCULATION OF THE AMOUNT OF THE BUILDING EXCISE TAX UNDER CHAPTER 144 OF THE DORCHESTER COUNTY CODE.

SECTION ONE: Acting under Chapter 144, Section 144-32 of the Dorchester County Code and Article 25-A, Section 5 (S) of The Annotated Code of Maryland (The "Acts") be it ENACTED AND ORDAINED by the County Council of Dorchester County, Maryland, in Legislative Session, that new Section 155-20.1 be added to Chapter 155 of the Dorchester County Code to read as follows:

CHAPTER 155 ZONING

Section 155-20.1: APPEALS FROM DIRECTOR OF PLANNING- CALCULATION OF BUILDING EXCISE TAX

The Board of Zoning Appeals is granted the authority to hear and decide appeals from the decision of the Director of Planning regarding the calculation of the amount of the Building Excise Tax under Chapter 144 of the Dorchester County Code

SECTION TWO: BE IT FURTHER ENACTED AND ORDAINED by the County Council of Dorchester County, Maryland that General Code Publishers is directed to codify new Section 155-20.1 of Chapter 155 of The Dorchester County Code accordingly.

SECTION THREE: BE IT FURTHER ENACTED AND ORDAINED that this Bill shall be known as Bill No. 2004- 24 of Dorchester County, Maryland and shall take effect sixty (60) days after it final passage.
