1 **SECTION ONE: BE IT ENACTED AND ORDAINED BY THE**
2 **COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND**
3 **that the Dorchester County Code be amended by adding Section XII to**
4 **Chapter 144, to be entitled "Homestead Property Tax Credit".**

6 **Chapter 144, Taxation, is amended by adding Section XII:**

8 **XII. Homestead Property Tax Credit**

10 **§ 144-44. Calculation of the Homestead Property Tax Credit.**

11
12 Pursuant to the authorization contained in Section 9-105, Tax-Property
13 Article, Annotated Code of Maryland, the homestead property tax credit
14 percentage is 105%.

16 **SECTION TWO: BE IT FURTHER ENACTED AND ORDAINED BY**
17 **THE COUNTY COUNCIL OF DORCHESTER COUNTY,**
18 **MARYLAND that General Code Publishers is directed to codify new**
19 **Article XII of Chapter 144 in the Dorchester County Code accordingly.**

21 **SECTION THREE: BE IT FURTHER ENACTED AND**
22 **ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER**
23 **COUNTY, MARYLAND that this legislation shall take effect July 1,**
24 **2006.**
