RESOLUTION ADOPTING A SCHEDULE FOR CIVIL PENALTIES

SCHEDULE OF CIVIL PENALTIES
FOR VIOLATIONS OF CHAPTER 78
OF THE DORCHESTER COUNTY CODE
ENTITLED "DOG CONTROL"

WHEREAS, Bill No. 2006-7 of the County Council of Dorchester County, Maryland relating to the County's authority, definitions, licensing and vaccinations, animal control, animal care, abuse and cruelty, and providing for enforcement of the regulations and penalties for violation of the Chapter entitled "Dog Control" was passed on October 3, 2006, and designated certain acts as civil infractions and provided for procedures, citations and civil penalties with regard to such acts; and

WHEREAS, the civil penalties for violations of the above mentioned law are to be set by the resolution of the County Council of Dorchester County, in regular session pursuant to Chapter 78, Section 78-11 (C).

NOW, THEREFORE, BE IT RESOLVED by the County Council of Dorchester County, Maryland in regular session, that the following schedule of civil penalties are hereby established.
