AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND PURSUANT TO THE AUTHORITY OF SECTION 10-202 AND SECTION 10-206 OF THE LOCAL GOVERNMENT ARTICLE OF THE ANNOTATED CODE OF MARYLAND TO REPEAL SECTION 63-5(L) OF CHAPTER 63, ENTITLED BURIAL SITES PRESERVATION OF THE DORCHESTER COUNTY CODE PROVIDING FOR THE REPEAL OF THE DUTY AND POWER OF THE BURIAL SITES PRESERVATION BOARD TO REVIEW AND PROVIDE ASSESSMENT AND COMMENT TO THE DORCHESTER COUNTY DEPARTMENT OF PLANNING AND ZONING REGARDING THE ESTABLISHMENT OF BURIAL SITE AREA BOUNDARIES FOR RECORDATION OF APPROVED BOUNDARIES IN THE LAND RECORDS OF DORCHESTER COUNTY, AS APPROPRIATE, AND TO REPEAL AND REENACT SECTION 63-5(M) OF CHAPTER 63 AND SECTION 63-5(L) OF CHAPTER 63 OF THE DORCHESTER COUNTY CODE.

SECTION ONE: Be it ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, that Section 63-5(L) of Chapter 63, entitled Burial Sites Preservation of the Dorchester County Code be and the same is hereby repealed.

SECTION TWO: Be it ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, that Section 63-5(M) be and is renumbered as Section 63-5(L) of Chapter 63 of the Dorchester County Code entitled "Burial Sites Preservation" to read as follows:

**Chapter 63**

**BURIAL SITES PRESERVATION**

**§63-5. Powers and duties of Board.**

The Board shall have the following powers and duties:

- L. To have available to it the advice and counsel of the County Attorney.

SECTION THREE: Be it further ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, that General Code Publishers is directed to codify the amendments herein enacted to Chapter 63 of the Dorchester County Code entitled "Burial Sites Preservation".

SECTION FOUR: Be it further ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, that this Bill shall be known as Bill No. 2022-10 of Dorchester County, Maryland and shall take effect sixty (60) days after its final passage or upon Critical Area Commission approval whichever is later.


SECTION FIVE: Be it further ENACTED, pursuant to Section 308 of the Charter of Dorchester County, Maryland, that promptly after enactment of this Act, the County Manager shall cause a fair summary of this Act to be published at least once in a newspaper of general circulation in Dorchester County, Maryland.
