A resolution of the County Council of Dorchester County, Maryland amending the 2004 Dorchester County Comprehensive Water and Sewer Plan map by changing the designation of an area of land located to the south and west of the City of Cambridge, MD, as identified on the attached exhibits, said land are being currently designated as "no planned service" or S-2 and W-2, to be amended and changed to S-1 and W-1 which means service existing or planned within the next two year time period.

Whereas, Maryland state law mandates that all Maryland counties adopt a Comprehensive Water and Sewer Master Plan and

Whereas, Dorchester County, Maryland has adopted its most recent and current Water and Sewer Plan on March 16, 2004; and

Whereas, a request was filed to amend the Comprehensive Water and Sewer Plan for certain properties located on the west and south side of the Town of Cambridge, MD and identified on the attached exhibits, including the attached text amendment and map amendments; and

Whereas, the Dorchester County Planning Commission reviewed the application and determined that this amendment is consistent with the Dorchester County Comprehensive Plan; and

Whereas, the County Council of Dorchester County, having held a public hearing regarding this matter on April 11, 2006, and having given careful consideration to the request, voted unanimously to amend the adopted Comprehensive Water and Sewer Plan.



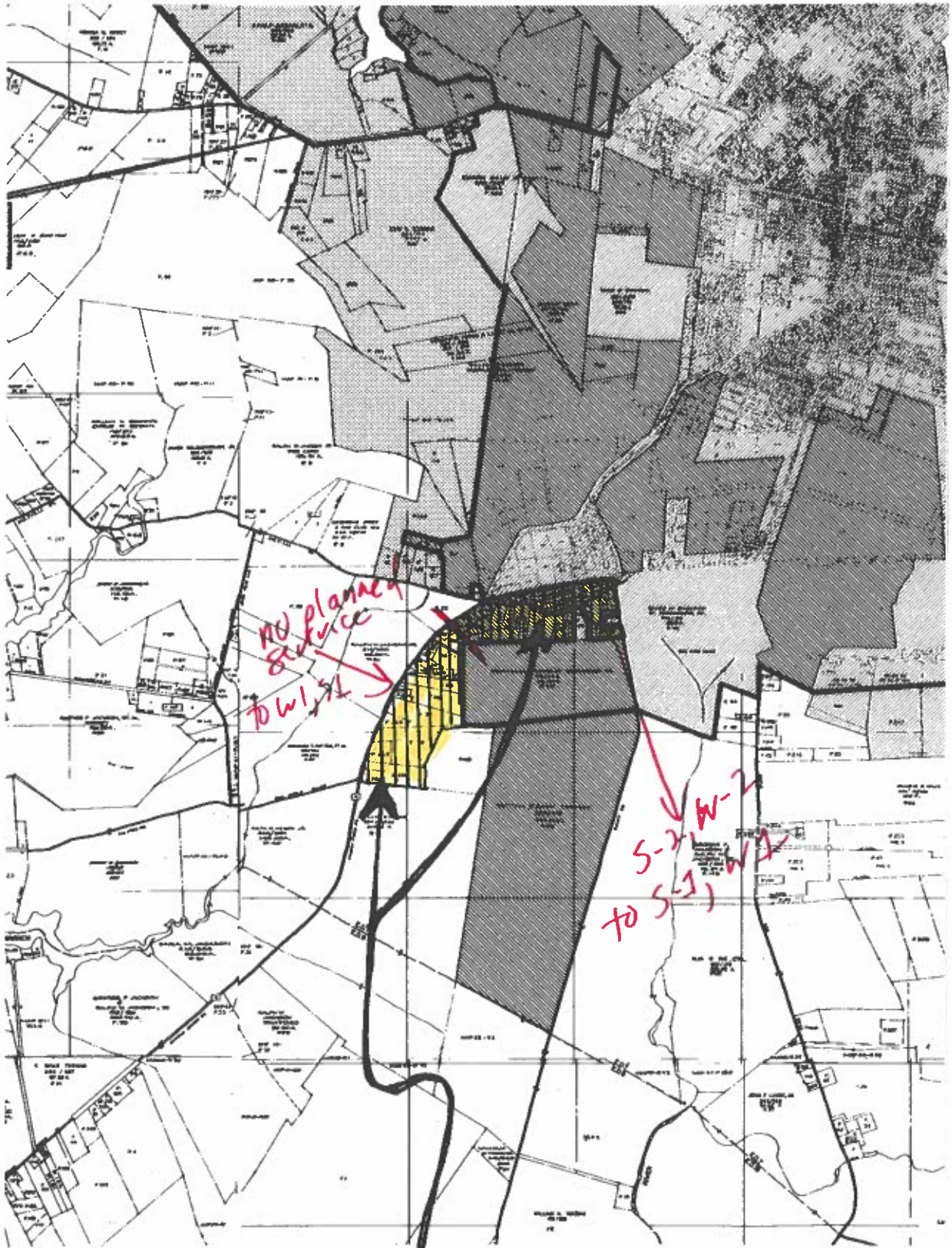
