

A RESOLUTION OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND AMENDING THE 2004 DORCHESTER COUNTY COMPREHENSIVE WATER AND SEWER PLAN (THE "PLAN") TO ADD OR DELETE CERTAIN PARCELS TO/FROM TABLE 4-1 (ENTITLED "WOOLFORD-MADISON SEWER PROJECT WASTEWATER ALLOCATION ESTIMATE) OF THE PLAN.

WHEREAS, State law mandates that all Maryland counties adopt a Comprehensive Water and Sewer Master Plan; and

WHEREAS, Dorchester County adopted its most current Plan on March 16, 2004; and

WHEREAS, the Dorchester County Sanitary District, Inc. filed to amend Table 4-1 of the Plan in order to correct or update the list of properties which will be eligible for connection to Sanitary District #7, said list being attached hereto and incorporated herein; and

WHEREAS, on December 2, 2009, the Dorchester County Planning Commission certified that the proposed amendments are consistent with the Dorchester County Comprehensive Plan; and

WHEREAS, the County Council of Dorchester County, having held a public hearing on this matter on January 19, 2010, and having given careful consideration to the matter, voted unanimously to adopt the proposed amendments.

NOW THEREFORE, BE IT RESOLVED, the County Council of Dorchester County, Maryland does hereby amend the 2004 Dorchester County Comprehensive Water and Sewer Plan, as set forth on the attached amendment.
