RESOLUTION OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND
CONSENTING TO AND MAKING APPLICATION FOR
41.24 ACRES WITHIN THE TOWN OF HURLOCK, DORCHESTER COUNTY, MARYLAND
TO BE DESIGNATED AS AN ADDITIOIN TO THE EXISTING ENTERPRISE ZONE BY THE MARYLAND
DEPARTMENT OF BUSINESS AND ECONOMIC DEVELOPMENT

WHEREAS, the State of Maryland has passed legislation providing for the designation of Enterprise Zones in political subdivisions of the State, and

WHEREAS, the purpose of such a zone is to focus local and State resources on the encouragement of economic growth in economically distressed areas of the State; and

WHEREAS, the Town of Hurlock has made application to the Maryland Department of Business and Economic Development to designate 41.24 acres within the Town, shown as Amendment to Exhibit A attached hereto, as an addition to the existing 611.75 acre Enterprise Zone, and

WHEREAS, the County Council of Dorchester County, Maryland desires to consent to and apply (jointly with the Town of Hurlock) to the Maryland Department of Business and Economic Development to designate said area as an addition to the Town of Hurlock's "Enterprise Zone."

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Dorchester County, Maryland that the County hereby consents to and jointly applies to the Maryland Department of Business and Economic Development to designate 41.24 acres within the Town of Hurlock, in Dorchester County, Maryland as an "Enterprise Zone." The boundaries of the Enterprise Zone, consisting of 652.99 acres within the Town of Hurlock, are shown on the attached map marked Amendment to Exhibit A.

BE IT FURTHER RESOLVED, that this Resolution shall take effect upon its passage.

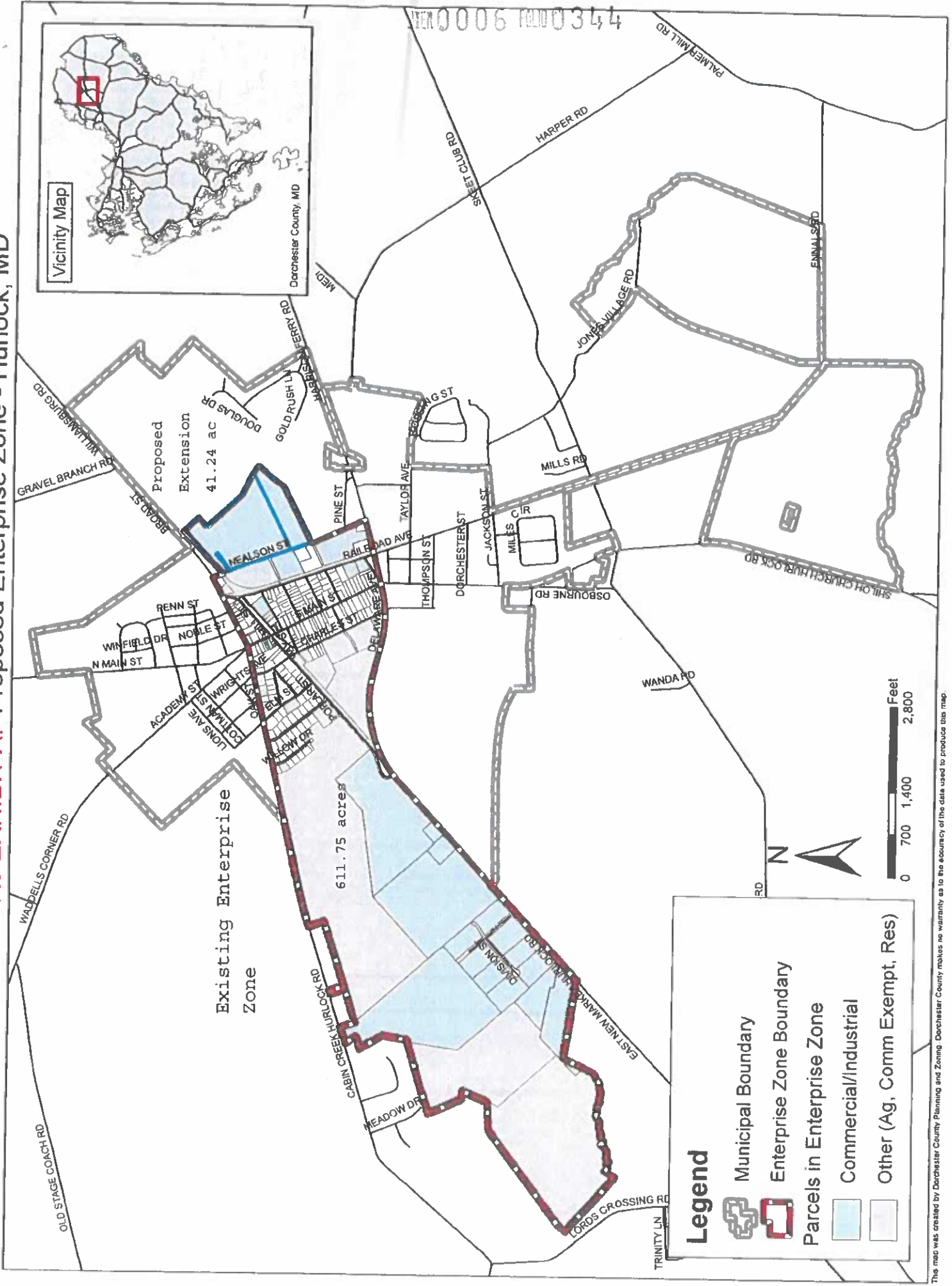
